Limiting VOC emissions by lowering the VOC content of coatings

Assess the need and benefit of the quart exemption

### Part 208 Landfill Gas Collection and Control Systems for Certain Municipal Solid Waste Landfills

Applies to "existing MSW Landfills" that accepted waste after 11/8/87 & began construction or modification before 7/17/14

Retain the applicability design capacity threshold of 2.5 million megagrams & 2.5 million cubic meters

Revise new emission guidelines as issued under 40 CRF Part 60, Subpart Cf on 8/29/16 which replaces Subpart Cc issued in 1996

Lower NMOC emission threshold from 50 Mg/year to 34 Mg/year for installing a gas colletion and control system (GCCS)

219-8 Small Municipal Waste Combustion Units Constructed on or before 08/30/99

219-9 Existing Sewage Sludge Incinerators

219-6 Existing NYC, Nassau & Westchester



#### **Part 219 Incinerators**

Various updates and clarifications to 219-4 Incinerators, Crematories

Add more stringent particulate standards for new crematories

#### Part 222 Distributed Generation Sources

Rule Effective December 1, 2016

Establish NOx emission limits for sources not subject to Subpart 227-2

#### Part 222 Distributed Generation Sources

Rule Applicability: 200 hp or greater in NYMA

400 hp or greater Upstate

Notification Requirement: January 2, 2017

Let DEC know that you have a source subject to the rule.



#### Part 222 Distributed Generation Sources

**Emission Limits for Engines** 

NOx:

Natural Gas-fired: 1.5 g/bhp-h

Diesel-fired: 2.3 g/bhp-h

Particulate Matter

Diesel-fired: 0.30 g/bhp-h

Natural Gas-fired: no PM

limit



#### Subpart 225-2 Fuel Composition and Use-Waste Oil as a Fuel

Past the public comment period

Includes Marine exemption Lower sulfur-in-fuel, PCB and lead limits in waste oil

Includes arsenic, cadmium & chromium limits

Remove out dated regulatory references

Stakeholder process underway

Review of NOx emission limits for peaking turbines

Limit NOx on High Ozone days

# Part 232 Perchloroethylene (perc) Dry Cleaning Facilities

Retitle Regulation "Dry Cleaning Facilities"

Reduce perc and alternative solvent emissions

Stakeholder meetings held

Early stage of development

Update to implement additional Volatile Organic Compound (VOC) product content limits

Effort to be regionally consistent throughout the Ozone Transport Region

#### Part 247 Outdoor Wood Boilers

EPA NSPS QQQQ in 2015 requires new unit testing and certification

Part 247 certification conflicts

Rule in early stage of development

Remove certification, labeling, and nuisance provisions

Change PM emissions to meet NSPS

Require older units that have moved to meet installation requirements as if new
